2. Preference may be given to the reasonable highest offered beyond the offset price subject to the satisfaction of all other relevant conditions.
3. Offers received late, incomplete, unsigned and without the required earnest money deposit are liable to be rejected.
4. The Corporation reserves the right to accept/reject any and or all offers without assigning any reason whatsoever thereof.
5. Conditional offers shall not be accepted.
6. Intending buyer(s) who will be submitting the tender shall appear before the Committee either in person or through his/her authorized representative. In case of authorized representative the offerer shall authorize the person in writing who will appear and negotiate on his/her behalf.
7. The Corporation reserves its option for further negotiation with the highest bidder.
