- The warranty period should be invariably mentioned and the warranty facility of the manufacturer should be passed on to the Corporation.
- The Vendor should be a bona-fide firm established as per law of the land and should be an authorised seller/dealer of the manufacturing company. The vendor should enclose document in support of the dealership licence issued by its principal.
- The equipments should be delivered in original in sealed packet of the manufacturer with packing list without any alteration. Tampered packet on any account would not be accepted.

7. The vendor(s) having dealership license of different manufacturers, shall quote separately for PBX systems of respective makes (i.e separately for Coral, Matrix, Siemens and Cisco system).
8. The vendor shall provide the post sale service as and when required and the AMC rate, after expiry of warranty period, should be invariably mentioned.
